Stéphane has over 30 years of experience as a projects and transactional lawyer. He has built a strong practice advising businesses on their environmental, social and governance (ESG) strategies and how they can align their activities with the UN's Sustainable Development Goals (SDGs). He was one of the experts advising John Ruggie (former UN Special Representative of the Secretary General on the issue of human rights and transnational corporations and other business enterprises) on the human rights capacity building obligations and responsibilities of States and multinationals.
